### 4. Course Requirements

Prerequisites: Economics 52 or equivalent

Examination: A mid-term examination to be held on Monday, April 28, 2003, 9:00-10:50 AM and a final examination to be held on Tuesday, June 10, 2003, 8:30-11:30 AM. Both the mid-term and the final examinations will be closed book. No early mid-term or final examinations will be offered. Students who miss the mid-term examination with legitimate reasons will be allowed to take a make-up mid-term examination to be offered within a couple of weeks of April 28. Students who miss the final examination with legitimate reasons will be allowed to take a make-up final examination early in the Fall Quarter of Academic Year 2003-2004.
